INSTRUCTIONS AND TERMS AND CONDITIONS FOR SUBMISSION OF TENDERS

1. Tender offers should be submitted in the prescribed tender form only. It should be super scribed as "Tender for Electrification Work For Rice Mill At Sulthan Bathery, Wayanad (Dist)" and addressed to the Managing Director, The Kerala Agro Industries Corporation Ltd., Thiruvananthapuram-695 023.
2. Tender must be accompanied by earnest money deposit of Rs. 17,500/- by way of Demand Draft infavour of the Managing Director, The Kerala Agro Industries Corporation Ltd., Thiruvananthapuram-695 023.
3. Forfeiture of EMD:- The EMD will be forfeited to company in case after submitting the tender, the tenderer withdraws his offer or fails to execute the agreement when called for to do so.
4. Preliminary agreement has to be executed in Kerala Stamp Paper worth Rs.200/-, along with the tender.
5. Tenders without EMD and preliminary agreement will be rejected.
6. Tenders should be accompanied by detailed specifications, catalogue etc of the components of the system.
7. The components using for the installation should be ISI marked and the details of manufacturers with ISI number is to be furnished.
8. The rate quoted should be for the electrification work of Rice Mill at Sulthan Bathery,Wayanad (Dist).
9. The tenderer shall supply all necessary accessories required for the successful completion of the work.
10. The tenderer shall undertake to assure all the electrical connections in perfect condition as per the work order.
11. Details of such works completed by the tenderer should be furnished.

12. Tender should be accompanied by performance certificate of same type of work already completed.
13. The successful tender will have to execute agreement in Kerala stamp paper worth Rs.200/- in the prescribed form and in the prescribed manner and furnish a security deposit of 5% of the total value of contract by way of DD/Bank guarantee. Any exemption on payment of security deposit would be allowed based only on production of Exemption Certificate by the Government.
14. The successful tenderer should undertake the work of electrification within one month from the date of placement of work order.
15. The successful tenderer has to provide performance guarantee amounting to 5% of the contract value, by way of Bank Guarantee covering the period of warranty, subject to a minimum period of one year from the date of completion of work.
16. Payment – 95% of the cost of work and materials after successful completion of electrification work and balance 5% after one month from the date of completion of work and submission of performance guarantee.
17. Submission of bills / invoices:- Bills addressed to Managing Director, The Kerala Agro Industries Corporation Ltd., “Kissan Jyothi”, Fort, Thiruvananthapuram-695 023 is to be submitted in triplicate to the Consignee along with all documents, advance stamped receipt etc.
18. Refusal to accept the items supplied:- In case the materials supplied are of lower quality than the specified, the Corporation shall have the right to reject such materials. In such cases, the successful tenderer will have to remove the items immediately at their own expenses and materials conforming to the specification should be supplied afresh. Supply of lower quality items will also be entailed as sufficient reason to terminate the contract.

Rate quoted should be for the electrification of Rice Mill At Sulthan Bathery, Wayanad (Dist) inclusive of all charges towards taxes, duty, freight, transportation, handling charges etc. applicable at the time of work. 20. Security Deposit shall not bear any interest.
21. Selected Contractor has to complete all statutory formalities for getting sanction from KSEB and connected Department.
22. (a) Release of Security Deposit:- Security deposit unless forfeited to the company in part or in full, will be refunded after the contract has been fulfilled and meeting all the contractual obligation.
(b) The EMD of the tenders who have not qualified in the bid will be refunded after finalizing the contract.
